

MEMORANDUM OF UNDERSTANDING (MoU)

Between Jharkhand Rai University (First Party)
and
Maa Ram Pyari Super Speciality Hospital, Ranchi (Second Party)

On 01/06/2024

This memorandum of understanding (MOU) was entered at Ranchi on 1st June, 2024. It is valid up to 31st May, 2029.

Agreement for the affiliated Hospital and the uses of Hospital facilities of Maa Ram Pyari Super Speciality Hospital, Ranchi for the practical training of Bachelor of Physiotherapy (BPT) students. Jharkhand Rai University, Ranchi for each year. No other institution is tied up to during this period.

Jharkhand Rai University is located at Raja Ulatu, Namkum Ranchi, is represented by Registrar Dr Piyush Ranjan hereinafter referred as first party.

Maa Ram Pyari Super Speciality Hospital is located at Harihar Singh Road, Bariatu, near Rajendra Institute of Medical Sciences (RIMS), Ranchi, Maa Ram Pyari Super Speciality Hospital is represented by founder Dr. S.N. Yadav of the hospital hereinafter referred to as the second party which expression shall unless repugnant to the context thereof, mean and include its successor and permitted assign.

Whereas the first party has established the Jharkhand Rai University, Ranchi by Jharkhand Rai University Act, 2011 (Jharkhand Act 03 of 2012) and approved by University Grant Commission (UGC) has approached the second party to agree as an affiliated hospital and use hospital practices for providing training and internship to their BPT students.

The first party will be responsible for arranging affiliation and recognition from the regulatory bodies and other legal authorities from time to time.

The second party has agreed to allow the student of BPT from Jharkhand Rai University, to come to the hospital and get themselves trained with the help of their professor's tutors/ Clinical hospital practice and instructors, using hospital facilities to gain hospital practice and education. The second party declare that the hospital shift duties is solely associated with Jharkhand Rai University throughout the year. No other Physiotherapy institution is tied to practice in the hospital except Jharkhand Rai University.

Whereas the first party has expressed its interest in using the clinical facilities for its university. The second party has agreed to such request through its trust. The second party has agreed to such request through its management to enter into a MOU. Whereas the second party has desired the following terms and conditions which the first party has agreed to form time to time.

- (1) The first party shall be responsible for affiliation and maintaining the regulation and recognition from regulatory bodies and other legal authorities including state government periodically, wherein the second party shall bear no responsibility or liability whatsoever in respect of any de-recognition.
- (2) The first party shall notify the second party in writing in advance about the schedule timetable and training related activities and internship including clinical examination etc.
- (3) The second party will be responsible for issuing the experience certificate after completion and has no role in functioning or following up the evaluation assessment of the activities of any other clinical functions or clinical training provided by the first party.
- (4) This Memorandum of Understanding (MOU) will be valid for a period of five years subject to review and agreement of terms thereof from the date of signing the MOU by both parties. The MOU can be terminated by either party at any time by giving one year notice in advance to the other party.
- (5) It is hereby specifically agreed between the first and second party that in case of any difference of opinion or interpretation of terms and conditions of this agreement or the functioning of the institution or any financial arrangement etc., dispute shall be settled through mutual discussion or arbitration.


