

# Agreement the DreamZ Scholarship Program

for the Academic Session 2025-26

## **Between Jharkhand Rai University, Ranchi, India and UNESCO Chair "Water, Women and Decision-Making Power"**

This Agreement is made on this June 10<sup>th</sup>, 2025, by and between:

**Jharkhand Rai University, Ranchi, India** has been established under "Jharkhand Rai University Act, 2011" by Jharkhand State Legislature as per section 2(f) of UGC Act 1956, is represented by **Agrataa K**, Single Point of Contact (SPOC) for the DreamZ Scholarship (hereinafter referred to as "University"),

AND

**UNESCO Chair "Water, Women and Decision-Making Power"**, represented by **Stanislas NONGBE**, Single Point of Contact (SPOC) for DreamZ Nominations (hereinafter referred to as "Nodal Agency").

### **Purpose & Scope:**

To nominate underserved girls to study under DreamZ Scholarship Program of Jharkhand Rai University. For the academic session 2025–26, 10 seats are reserved under the UNESCO Chair 'Water, Women, and Decision-Making Power.

### **Terms & Conditions:**

- The Nodal Agency will nominate underserved girls from remote areas for the DreamZ Scholarship Program, ensuring their admission into designated programs as per the University's prescribed guidelines.
- The tuition fee for the entire duration of the program shall be covered by Jharkhand Rai University, Ranchi, India.

- The Nodal Agency will be responsible for identifying sponsors to bear the cost of hostel accommodation. Please note that hostel accommodation for foreign nationals will be separate from that of students of Indian nationals, and the charges for foreign nationals may vary accordingly.
- The Nodal Agency shall be responsible for verifying the eligibility documents of the nominated girls on the basis of the University guidelines provided. If any false information or misinterpretation is detected, University reserves the right to cancel the admission at any stage.
- The Nodal Agency shall be responsible for assessing the financial status of the nominated girls. In future, if it is found that the student's financial status does not meet the eligibility criteria for the DreamZ scholarship; in that case University reserves the right to withdraw the scholarship. The student will be required to pay the entire tuition fees.
