Notification

In pursuance of section 38 (chapter 6) of Jharkhand Rai University Act 2011 (Jharkhand act 03 of 2012), the following committees of Jharkhand Rai University, Ranchi are hereby being notified and terms of membership of the committee other than ex-officio (Member Secretary) shall be three years from the date of notification, after due consideration of the Vice-Chancellor of the University the next term may be extended for further three years or any member also may be removed from the concerned committees:

A). Discipline committee: The committee shall consider all cares of indiscipline on the part of teachers, officers and other staffs of the University and make its recommendations for decision by the authorities concerned. The committee shall consist of the following:

- (i) The Vice Chancellor-Chairman
- (ii) The Pro Vice-Chancellor (Administration) - Member
- (iii) Two H.O.Ds. of the University to be nominated as members by the Vice-Chancellor
- (iv) One Senior teacher among the University teachers - Member
- (v) The Registrar-Member Secretary

B). Press Media Committee: The committee shall look after all the media events, press conference arrangement and press release related to University. The committee shall consist of the following:

- i). The Registrar- Chairman
- ii). Mr. Sabyasachi Chakraborty - Member
- iii). Mr. Pramod Kumar - Member
- iv). Mr. Prashant Jaiwardhan - Member
- v). Arindip Diwan - Member Secretary

C). Library Committee: This committee will be responsible for overall development and proper maintenance of the University library including budget preparation and digitalization of library etc. and make its recommendation to the Vice-Chancellor for due approval. The committee shall consist of the following:

- (i) The Registrar-Chairman
- (ii) All H.O.Ds of Department and Finance Officer - Member
- (iii) Two teachers to be nominated by the Vice Chancellor - Member
- (iv) The Librarian or Assistant Librarian – Member Secretary

D). Student's Discipline Committee: This committee shall examine and consider all cases of indiscipline related matters on the parts of students and make its recommendation to the Vice-Chancellor. The committee shall consist of the following:

- i). The Registrar – Chairman
- ii). Mrs. Shiny TC - Member
- iii).Dr. Leena Shrivastawa - Member
- iv). Dr. Vikas Kumar Sinha - Member
- v). Prof. Anupma Verma – Member
- vi). Prof. Sabyasachi Chakraborty – Member Secretary
- vii). Prof. Sweta Singh – Member

E). Purchase and sale committee: The committee shall consider annual requirements of University's store including examination stores, shall open and consider tenders and the sample and makes its recommendations to the Vice-Chancellor for purchase to be made from time to time.

The committee shall conduct action and make arrangement for the sale of saleable goods, articles, orchard etc. of the University estate. The committee shall consist of the following:

- i). The Registrar – Chairman
- ii). Mr. Cherian Jacob – Member
- iii). Shiny TC – Member
- iv). Dr. Leena Srivastava – Member
- v). Dr. Ashfaq Alam – Member
- vi). Dr. Vikash Sinha – Member
- vii). Prof. Sabyasachi Chakraborty – Member
- viii). Mr. Satya Prakash Rai – Member Secretary

F). Equivalence Committee: The committee shall scrutinize the case for giving equivalence to the examinations conducted by other University / autonomous Institutions and make its recommendation for consideration of the Academic Council. The committee shall consist of the following:

- i) The Vice- Chancellor – Chairman
- ii) The Registrar – Member Secretary
- iii) The Controller of Examinations
- iv) Deputy Registrar - Exam
- v) Deans / H.O.Ds. of the Department Concern

G). Academic and Examination Calendar committee: The committee shall prepare University Academic and Examination Calendar in each year on half yearly basis. The Academic and Examination calendar should contain the date of starting the teaching and examinations and make its recommendation to the Vice- Chancellor for due approval. The committee shall consist with the following:

- i). The Registrar – Chairmen
- ii). All Deans and H.O.Ds. – Member
- iii). Controller of Examinations – Member Secretary

Please consider that cited above information are modified to such extent. The Vice-Chancellor shall have power to restructure the above said committees as and when required.
